RDA AND ITS DEVELOPMENT

What is RDA?

RDA = Resource Description and Access

- New metadata standard for cataloguing
- Designed for the digital environment
- Better metadata to support better resource discovery
- Replaces AACR2

Development of RDA

- 1998-2004 Revisions to AACR2
- 2004 AACR3
- 2005 RDA: Resource Description and Access
- May 2008 LC, NAL, NLM announce RDA testing to determine implementation
- 2009 RDA text completed

U.S. RDA Test: Key Dates

- January 2010 Full-day Train the Trainer session for testers
Files posted on LC's website
- June 2010 RDA Toolkit released
- July-Sep. 2010 Phase 1: “Learning Curve” period
- Oct.-Dec. 2010 Phase 2: Formal test record submission period
- January 2011 Phase 3: Data analysis begins
- June 2011 Report and recommendations made public
Recommended implementation no sooner than
January 2013 (U.S. RDA Test Coordinating Committee, 2011)

U.S. RDA Test: Select Recommendations Completed

- Reworded RDA instructions in clear, unambiguous plain English
- Defined process for updating RDA in online environment
- Improved functionality of the RDA Toolkit
- Developed full RDA record examples in MARC and other encoding schemas
- Demonstrated progress towards replacement of MARC
- Led and coordinated RDA training

- Involvement in consortia
 - Shared catalogued?
- Cataloguing output

Your Cataloguing Output

- Original cataloguing
 - What percent of cataloguing is original cataloguing?
 - Who is doing original cataloguing?
 - Librarians or support staff?
 - How many?
 - Is it outsourced?
 - MARC or non-MARC?
- Copy cataloguing
 - Do different people do basic and complex copy cataloguing?
 - Where are the records coming from? Are they implementing RDA?

RDA Implementation Scale



No RDA Records

- Not implementing RDA
- All copy cataloguing records are AACR2
- Records do not contain RDA elements
- In OCLC, don't downgrade RDA master records to AACR2
 - Edit locally only
- Sample situations
 - Using card catalogue
 - Using non-MARC system
 - Almost all materials require original cataloguing
- Becoming less and less likely!

RDA Copy Cataloguing

- Will you accept AACR2 and RDA? **YES!**
- How much cataloguer's judgment?
- Checklist
 - Presence/absence of MARC fields
 - 050/090, 245, 250, 6XX (at least 1), 300\$e if accompanying material, etc.

Day One for Original Cataloguing

- Is there an RDA Day One?
 - No, but some libraries followed LC's date of March 31, 2013
- Does my library need an RDA Day One?
 - NO, but establishing a Day One may be helpful
 - If part of consortium or shared catalogue
 - Support from colleagues
 - Establish a realistic Day One and stick to it
 - Your goal date to be cataloguing in RDA
 - Can establish different Day Ones based on format
 - Start with print monographs

Original Cataloguing

- Develop community of practice to support each other
 - Collaborating with colleagues in your institution or nearby institutions
- Review structure
 - Can use OCLC record review files or online save file
- E-mail lists or groups to ask for help
 - RDA-L
 - AUTOCAT
 - CLA's Technical Services Network
 - Create your own

 - 2 cataloguing librarians

 - 6 Derived Cataloguers & Orders Assistants
 - 1 Authorities Assistant

- 2011-2012 cataloguing output (MARC)
 - 42,708 physical & electronic titles
 - 20,060 physical volumes
 - 22,648 electronic titles
 - 204 RDA copy cataloguing records


RDA Records at Concordia

 - 1 CD-ROM


Original RDA Cataloguing at Concordia

- Original cataloguing is almost entirely done by librarians
 - High level support staff may derive new records, which are reviewed by a librarian
-
- March 2013 First original RDA records
 - April 1, 2013 Day one for print monographs in RDA
 - Summer-Fall 2013 RDA original cataloguing for all formats
-
- 111 original RDA records (2% of the total RDA records)
 - Includes print and electronic monographs, DVDs, streaming video, score


RDA Records Catalogued at Concordia

Costs to Implementation

- Higher, unavoidable short-term implementation costs
 - Subscription to RDA Toolkit
 - Development of training materials
 - Creation/revision of documentation and policies
 - Decreased productivity for training and learning
- On-going cataloguing costs are comparable to AACR2 for original and copy (Maurer, 2013)
- Heading creation and authority control are expensive (Maurer, 2013)

Training Methods Tips

- Offer a variety of training methods
 - Standard seems to be 2 day training sessions (can be broken up)
- Coordinate training when possible
 - e.g., pair up with another local library
- Provide lots of opportunities for practice exercises
- RDA training is not finite
- “Can never undertrain for RDA” (Maurer, 2013)

What to Teach: Advice from Erin Stalberg

- “Do not obsess over types of materials you do not often collect or things that you do not routinely do”
 - Parts of the Bible
 - Rare books
 - Treaties
 - Music
- Authority records
 - Do you need to create RDA authority records or just be able to read one?
- “What do you really need to know and when?” (Stalberg, 2013)

- Will you follow LC-PCC PS?
 - Where will you differ?
- Document your decisions

Local Documentation

- Understand what you are doing before developing
- Updating local documentation can be time consuming
 - Start by revising AACR2 documentation for RDA
 - Adapting another library's RDA documentation
- Make local documentation available using:
 - Staff shared drive
 - Library intranet site
 - Website, wiki, libguide, etc.
 - Workflows in RDA Toolkit
 - Implementation spreadsheet

General Material Designator (GMD)

- Bracketed information in the title that conveys the type of material
 - *Examples:* [electronic resource]
[sound recording]
[videorecording]
- Replaced by three elements in RDA
 - Content type 336 `text $2 rdacontent`
 - Media type 337 `computer $2 rdamedia`
 - Carrier type 338 `online resource $2 rdacarrier`

What to do about GMD going away?

- “It was the only good thing about AACR2”
- OCLC will likely remove the GMD from WorldCat records after March 31, 2016
- There are much better options!

What to do about GMD going away?

- Icons may be based on:
 - Item data
 - ILS fixed field codes – may be based on MARC leader/fixed fields
 - 33X fields
- If icons are not possible:
 - May continue adding GMDs to RDA records in local ILS only, as a temporary measure
 - Work with ILS vendor to develop a sustainable solution
- If using icons, will you continue to display GMDs in AACR2 records?

New MARC 33X Fields

- Display to public? Some libraries are
 - Display all? Only content and carrier types
 - What labels to use? Content type; Format
- Indexing
 - Should 33X fields be indexed?
 - In keyword index or special index?
- “Require national best practice for effective display and use of the 336, 337, and 338 fields that will cut across vendor platforms and library communities” (Maurer, 2013)

New MARC 264 Field

- Confirm field 264 is being loaded correctly
- Does the field display in OPAC?
- Do labels need to be updated based on second indicator?
- Can you sort results by date?
- Can you limit by publisher?

Relationship Designators

- Subfield \$e in 100, 110, 700, 710 fields
- Subfield \$j in 111, 711 fields
- Subfield \$i in 7XX
- Should relationship designators be indexed?
 - Does indexing them create a split file?
 - Verify they are not inadvertently being indexed
- Accept relationship designators in copy?
- Add relationship designators for copy? Original?
- Show in OPAC or suppress?
- *Generally, do not delete unless incorrect*

Relationship Designator Best Practices

- PCC Guidelines for the Application of Relationship Designators in Bibliographic Records
 - <http://www.loc.gov/aba/pcc/rda/PCC%20RDA%20guidelines/Relat-Desig-Guidelines.docx>
 - Use the most specific term from RDA appendices
 - May you RDA element names if nothing more specific applies
 - Include if relationship is clear
 - Do not assign if can't define relationship
 - If more than one, repeat \$e and record in WEMI order
 - Include \$i relationship information even if field coding already expresses the relationship



HYBRID RECORDS

Upgrading AACR2 Copy to RDA

- *Optional*
- Do so with the “piece in hand”
- Examine and adjust the entire record
- Remove the GMD, if present
- Note: You can add RDA elements without upgrading to RDA

Hybrid Records

- Non-RDA records with some RDA elements added
- Possible RDA elements in non-RDA records
 - Adding relator terms to access points
 - Spelling out non-transcribed abbreviations
 - Adding complete statements of responsibility in MARC 245 (instead of “[et al.]”)
 - Adding MARC 336/337/338 fields
- Do NOT code as RDA without re-cataloguing the entire record
- Leave the GMD already present in the record

Examples of Possible Hybrid Record Changes

- Add relator terms
 - 100 1 Webster, Christy, **\$e author.**
- Spell out non-transcribed abbreviations
 - 300 1 **v.** (unpaged) : \$b col. ill. ; \$c 17 cm. *becomes:*
 - 300 1 **volume** (unpaged) : \$b **color illustrations** ; \$c 17 cm
- Complete statements of responsibility
 - 245 00 Gramsci : \$b space, nature, politics / \$c edited by Michael Ekers ... [et al.]. *may become:*
 - 245 00 Gramsci : \$b space, nature, politics / \$c edited by Michael Ekers, **Gillian Hart, Stefan Kipfer and Alex Loftus.**

Why Machine Manipulation?

- To incorporate various useful RDA practices in legacy records
- Ensures legacy records are as functional as possible in the future RDA environment
- Greater consistency of practice will allow for easier migration to a post-MARC world

Heading Changes

- Changes to how certain access points are constructed in RDA
- Phase 1:
 - Identify records that cannot be used under RDA (~400,000 records)
 - 667 THIS 1XX FIELD CANNOT BE USED UNDER RDA UNTIL THIS RECORD HAS BEEN REVIEWED AND/OR UPDATED
- Phase 2:
 - Change text of fields and recode as RDA
 - ~400,000, 30,000 records per day and completed in March 2013
 - These changes affect everyone who uses the LC/NACO Authority File

Managing Local Heading Changes

- Will be time consuming and expensive
- Split files are inevitable
 - Time consuming to fix
 - May require manual manipulation
- Option 1: Vendor-Provided/Automated Authority Control
 - Vendors
 - Backstage Library Works (http://bslw.com/authority_control/)
 - Library Technologies, Inc. (<http://www.authoritycontrol.com/>)
 - MARCIVE (<http://home.marcive.com/authority-control/>)

Managing Local Heading Changes

- Option 2: Systematic and Strategic Updates
 - Searching for and updating records based on machine manipulations made to LC/NACO Authority File
 - Might start with those that are likely to create problems
 - Bible headings
 - Dept. → Department
- Option 3: “Laissez-faire”
 - Be aware of changes made to access points
 - Update headings as they are used in your daily work to avoid split files in your ILS
 - Accept that your authorities may not match the current authority in LC/NACO Authority File

Authority Control in RDA

- Decide what is acceptable for you and your users
 - What were your authorities and headings like pre-RDA
- Determine resources and expertise available to correct and update headings
- “Don’t sweat the small stuff, but pay attention to those which are likely to create problems” (Maurer, 2013)

In Conclusion...

- Make sure your system behaves the way you want it to
- Accept RDA copy
- Work towards original RDA cataloguing of print monographs
 - Then focus on other formats
- Maintain access points as much as deemed necessary
